# Cookies Policy

## 1. Introduction

Afterprime Europe Limited (hereinafter “**We**”, “**Us**”, “**Our**”, “**Afterprime**”, the “**Company**”) is authorized, licensed and regulated as a Cyprus Investment Firm (‘**CIF**’) by the Cyprus Securities and Exchange Commission (‘**CySEC**’) under license number 368/18 and is operating in accordance with the provisions of the ‘**Investment Services and Activities and Regulated Markets Law of 2017**’ (L.87(I)/2017) regarding the provision of investment services, the exercise of investment activities and the operation of regulated markets’ (the “**Investment Services Law**”), as the same may be in force from time to time and modified and amended from time to time.

When you use our website, Afterprime will use cookies to distinguish you from other users of our website. This helps us to provide you with a more relevant and effective experience when you browse our website, including presenting websites according to your needs or preferences and it allows us to improve the site generally. All websites that operate across certain parts of the European Union are required to obtain consent when using or storing cookies on your computer or mobile device. This Cookie Policy (hereinafter the “**Policy**”) provides you with comprehensive information about the cookies we use and the way in which we use them.

## 2. What are Cookies?

Cookies are small files of information that often include a unique identification number or value, which are stored on your computer’s hard drive as a result of you using our website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies as soon as you visit our website.

Cookies are frequently used on many websites on the internet, and you can choose if and how a cookie will be accepted by changing your preferences and options in your browser. Some of our business partners (e.g. advertisers) use cookies on our website(s). We have no access to, or control over, these cookies.

The cookies do not contain personally identifying information nor are they used to identify you. You may choose to disable the cookies. However, you may not be able to access some parts of our website if you choose to disable the cookie acceptance in your browser, particularly the secure parts of the website. Some of our business partners may use cookies on or website(s). We have no access to, or control over these cookies. The cookies do not contain personally identifiable information nor are they used to identify you.

## 3. Why do we use Cookies?

We use cookies on our website and trading platforms to:

- recognise you whenever you visit this website (this speeds up your access to the website as you do not have to log in each time);

- obtain information about your preferences, online movements and use of the internet;
- carry out research and statistical analysis to help improve our content and to help us better understand our visitor/customer requirements and interests;
- to personalise content and ads, to provide social media features and to analyse our traffic;
- to differentiate users who use the same network to enable us to correctly allocate transactions to the appropriate account;
- to internally identify clients by account, name, email address, client ID, currency and location (geographic and computer ID/IP address);
- to make your online experience with us more efficient and enjoyable.

## 4. Description of Cookies

**Necessary cookies** help make the website usable by enabling basic functions like page navigation and access to secure areas of the website.

**Preferences cookies** enable the website to remember information that changes the way behaves or looks, like your preferred language or the region that you are in.

**Statistics cookies** help website owners to understand how visitors interact with websites by collecting and reporting information anonymously.

**Marketing cookies** are used to track visitors across websites. The intention is to display ads that are relevant and engaging for the individual user and thereby more valuable for publishers and third- party advertisers.

**Unclassified cookies** are cookies that we are in the process of classifying, together with the providers of individual cookies.
